Applicants not entering online must provide an entry form and mandatory release form. Foreign players must be endorsed by their respective federations. **Entry fee of \$110 (U.S. dollars drawn on U.S. banks), includes T-Shirt. No phone or fax entries will be accepted. No refunds will be made after November 15th, for either main draw or qualifying draw. Before November 15th, \$75 will be refunded. Semi Finals and Finals will be played December 22nd and December 23rd at the University of Miami Tennis Center.

12 & UNDER MAIN DRAW MATCHES

12 & Under Boys' main draw will be limited to 128 players. 16 spaces in the main draw will be reserved for qualifying players. Girls' 12 & Under main draw will be limited to 128 players. Preferences will be given to nationally and internationally ranked players. Acceptance will be at the discretion of the Junior Orange Bowl Committee. All foreign players must be endorsed by their respective federations who must state the order of merit. A minimum of 16 spaces in the Girls' main draw will be reserved for qualifying players.

Boys' 12s' Main: will be played December 17th thru December 22nd (December 23 rain day) at Salvadore Park, 1120 Andalusia Avenue, Coral Gables 33134 (clay courts). **Girls' 12s' Main:** will be played December 17 thru December 21 at the Biltmore Tennis Center, 1150 Anastasia Avenue, Coral Gables 33134. Semi finals and finals will be played December 22 and December 23 at the University of Miami Tennis Center, 5821 San Amaro Drive, Coral Gables, 33146.

SURFACE

12 & Under boys will be played on clay courts. 12 & Under girls will be played on hard courts.

BOYS & GIRLS 12 & 14 RULES & REGULATIONS

Two matches per day may be scheduled. Night play and a third match in one day may become necessary. Play will be 2 out of 3 sets. The Twelve Point Tiebreaker will be used in all sets. Scoring may be changed due to weather conditions. The U.S.T.A. Point Penalty System will be enforced. Five minutes warm-up, including practice serves will be allowed. A new can of balls will be used for the third set. Default time is 15 minutes. **NO SPECTATOR COACHING DURING MATCHES WILL BE PERMITTED. NO SPECTATORS ALLOWED ON COURTS.**

ALTERNATE SITES MAY BE USED IF NECESSARY.

THERE WILL BE A FULL FEED-IN CONSOLATION THROUGH THE QUARTER FINALS FOR ALL DIVISIONS. Play is **expected**. There will be a 3rd and 4th place playoff which play is **expected**. Awards will be given. Singles only. **There are no doubles in this tournament.**
